A common method for preserving trade secrets in such a situation is for the trade secret owner and the other party to enter into a Non-Disclosure Agreement (NDA) of some type. If the NDA contains a time limit on its non-disclosure obligation, then the expiration of that time limit may jeopardize the trade secrets covered by the NDA.

However, it is worth also exploring what constitutes a trade secret in California. The leading case is *Uribe v. Howie*, 19 Cal. App. 3d 194, 211 (1971), in which the court held that pesticide spray reports filed with the state agricultural commissioner were not trade secrets, and therefore were not exempted from disclosure under section 6254(k).
